Rules and Regulations

General Rules:

1. The Festival will be open from 10:00 a.m. to 4:00 p.m. on Sunday, September 10, 2023, with an inclement weather date of Sunday, September 17, 2023
2. Spaces will be assigned with due consideration to exhibitors' specific requests; however, the Chamber of Commerce reserves the right to make final space assignments. Exhibitors may not permit other Exhibitors to use their space, or any part thereof, without express written permission of the Greater Catonsville Chamber of Commerce.
3. Exhibitors must provide their own method of display, including table(s) and standard tents or canopies.
4. If an Exhibitor fails to occupy the space contracted for by the end of the scheduled set-up time or fails to comply in any other respect with the terms of this agreement, the Chamber of Commerce shall have the right to use such space in any other manner without releasing the Exhibitor from paying the registration fee based on the date of postmark.
5. Exhibitors should bring their confirmation letters on the day of the festival and must display vendor-parking passes on their vehicle dashboards for entrance to the grounds and parking lot.
6. The Exhibitor absolves the Greater Catonsville Chamber of Commerce, their officers, directors, employees, and agents of all responsibility for the protection of Exhibitor spaces, contents, and vehicles.
7. Exhibitors may open their booth at 9:30 a.m. and **MUST stop sales at 4:00 p.m.**
8. **The festival will proceed rain or shine. The Chamber of Commerce assumes no responsibility for exhibits. If weather conditions or other physical conditions present a danger to participants, The Chamber of Commerce may revert to the rain date of September 17, 2023. No refunds will be given.**
9. No pets, rollerblades, scooters, skateboards, or bicycles, please.

Exhibitor Space Dimensions:

1. Single space size is 10' wide x 10' deep.
2. Tents/canopies must protrude no further than 10'.
3. Exhibitors must remain within the confines of their spaces. No soliciting is allowed outside of the designated space.

Setup and Removal of Exhibit:

1. CAA will be closed to the public beginning at 6:00 a.m. on September 11, at which time Exhibitors may begin to set up their exhibits. **Vehicles must be removed from the exhibitor area as soon as they are unloaded—by 9:00 a.m. at the latest.**
2. The festival ends at 4 p.m. and **all Exhibitors must remove their exhibits by 5:30 p.m.** Exhibitors must clean up their spaces at the end of the day.

Traffic and Parking: In August, a Festival Map will be sent to exhibitors with space confirmation and parking instructions. Only vehicles with vendor parking passes will be permitted to park in designated lots. **Exhibitors may not park in spaces reserved for festival patrons.**

Sales and Use Tax Regulations:
